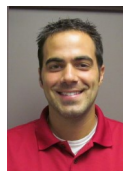

TUITION

Individuals are sponsored by their business or organization, or you may nominate themselves. Tuition for the program is \$400 per Chamber member participant and traditionally paid by the participant's employer, business or sponsoring organization. (Non-member tuition is \$600.) Installment plans are accepted. Also, one scholarship is available to qualifying non-profit participant.*

COMMITMENT

Participants are expected to make a commitment to the Van Wert County Leadership Program. The class meets one day a month usually from 8am—4pm. Participants are also expected to work on a community project. Absences or lack of participation in any part of the program may result in a participant leaving the program or making up absences the following year.

BOARD PARTICIPATION

Participants will be matched up with a local community non-profit Board of Directors. During the class year they will attend 2 board meetings with their selected board and will give a brief report on their experience to the class. This is a mandatory part of the program.
